

## Election 2024: The Arizona Answer Sheet

Tuesday, **November 5, 2024**, is GENERAL ELECTION DAY. *The mail-in ballots will be sent to voters on October 9th, the day early voting begins.* If you live in Pima County voter precinct 84 or 140, your **Democratic** neighbors urge you to **vote for ALL of the following candidates for State and local government offices.** The people you elect to these offices take actions **every day** that affect your continued well-being.

**JUSTICE OF THE ARIZONA SUPREME COURT [IN "SECTION TWO - NON-PARTISAN BALLOT]:**

**NO to BOLICK, CLINT**      **NO to KING, KATHRYN H.**

Both of these Justices voted to enforce the 1864 law banning abortion and mandating prison sentences. Both were appointed by Governor Ducey, a Republican supporter of extremists; neither had been a judge. Both are members of the ultra-conservative Federalist Society.

**THE BALLOT MEASURES (PROPOSITIONS):**

*NOTE* that propositions, if passed, can only be changed by a statewide vote or a supermajority of the legislature. **If you don't understand or don't agree with ALL parts of a measure, vote NO** and work for change within the legislature.

**139: YES** to the "ARIZONA ABORTION ACCESS ACT"- An amendment to the AZ Constitution proposed by a Citizens' Initiative signed by more than 800,000 voters. Restores the fundamental right to safe and legal abortion that existed under *Roe v. Wade*, prevents the state's interference before fetal viability, and protects access after fetal viability for the patient's physical/mental health.

**ALL OTHERS: NO.** The others are 11 Referenda by the Republican-controlled Legislature and one well-intentioned but dangerously flawed Citizens' Initiative (#140). One-third of current AZ legislators are "election deniers"; these Referenda aim at restricting voters' rights, politicizing the judiciary, and unbalancing the structure and workings of government. *See the next page for details.*

★ **Important note: YOU ARE ALLOWED** by law to look at this or any paper when you are in the voting booth, but you must not display any candidates' names in the polling place. Please put this paper in your pocket before entering the polling place, and look at it only in the privacy of the voting booth; otherwise you might not be permitted to enter the polling place.
