Tuesday, **August 28, 2014**, is **PRIMARY ELECTION DAY**, when Arizona voters go to the polls to nominate their political parties' candidates for the General Election. *The mail-in ballots will be sent out to voters on August 1st.* Your Democratic neighbors urge you to review the complete list of **Democratic Primary candidates for State and local government offices**, even though there is no contest in some races.
